Regarding the Recognition of Eligibility to Enroll in English for Specific Purposes for Full-time Undergraduate Students in the December 2025 Batch

HEREBY DECIDES:

Article 1: Recognition of English proficiency in the general training stage (equivalent to English proficiency according to the 6-level foreign language proficiency framework for Vietnam) for 66 full-time university students in December 2025.
