Regarding the Recognition of Eligibility to Enroll in English for Specific Purposes for Full-time Undergraduate Students in the June 2026 Batch

Pursuant to Notice No. 715/TB-ĐHNH dated May 15, 2026, regarding the update of the appendix on Foreign Language Standards and Information Technology Standards for undergraduate programs at Ho Chi Minh City Banking University;

Pursuant to the announcement on the enrollment process for candidates admitted to the standard full-time undergraduate programs of annual cohorts;

At the suggestion of the Head of the Department of Academic Affairs.

HEREBY DECIDES:

Article 1: Recognition of English proficiency in the general training stage (equivalent to English proficiency according to the 6-level foreign language proficiency framework for Vietnam) for 39 full-time university students in June 2026.
