DECISION

Regarding the recognition of full-time undergraduate students eligible to undertake the graduation thesis – Batch 5, Academic Year 2025–2026

Pursuant to Decision No. 1075/QĐ-DHNH (May 8, 2019) of the Rector on the promulgation of the “Regulations on grade management on the academic management software system at Ho Chi Minh City University of Banking”;

Pursuant to Decision No. 2181/QĐ-DHNH (October 4, 2019) of the Rector on the promulgation of the “Regulations on formal undergraduate training under the credit-based system at Ho Chi Minh City University of Banking”;

Pursuant to the Training Regulation No. 1575/QĐ-DHNH (August 31, 2021) of the Rector on the amendment and supplementation of certain articles of the formal undergraduate training regulation under the credit-based system issued under Decision No. 2181/QĐ-DHNH (October 4, 2019);

Pursuant to Resolution No. 159/NQ-DHNH-HĐT (September 16, 2022) on the promulgation of the Regulations on functions, duties, powers, and organizational structure of units under Ho Chi Minh City University of Banking;

Pursuant to Decision No. 466/QĐ-DHNH (February 28, 2024) of the Rector on the promulgation of the Regulations on organization and management of undergraduate training at Ho Chi Minh City University of Banking;

Based on the list of students registered to undertake the graduation thesis along with their proposed thesis titles, the recommendation for supervisor assignment from the academic departments, and the students' academic performance;

Considering the proposal of the Head of the Academic Affairs Office.

HEREBY DECIDES:

Article 1. Recognize the following 46 full-time undergraduate students as eligible to undertake the graduation thesis course – Batch 5, Academic Year 2025–2026.

Article 2. The academic departments and assigned academic supervisors are responsible for guiding students in completing their graduation theses in accordance with current regulations and policies. The timeline for conducting and evaluating the graduation theses is as follows:

-Thesis implementation and submission: 10 weeks, From September 14, 2026 to November 20, 2026 [From Week 03, Semester 1 to Week 12, Semester 1, Academic Year 2026–2027] .

- Thesis review and establishment of the Thesis Evaluation Committee: Weeks 13 and 14 of Semester 1, Academic Year 2026–2027.

- Thesis defense and evaluation: Weeks 15 and 16 of semester 1, Academic Year 2026–2027.

Article 3. The Chief of Office, Head of the Academic Affairs Office, Head of the Testing, Head of the Department of Finance and Accounting, Head of the Information Technology Management Office, the academic departments responsible for the respective majors, The faculty members assigned as academic supervisors and the students listed in Article 1 shall be responsible for implementing this Decision./.
