## **ANNOUNCEMENT**

Regarding course registration for the Regular Undergraduate Program and the Part-Time Undergraduate Program for Semester 1 – Academic Year 2025–2026

Pursuant to Decision No. 2181/QĐ-ĐHNH dated October 4, 2019 of the Rector on promulgating the Regulations on full-time undergraduate education under the credit-based system at Ho Chi Minh University of Banking; Pursuant to Decision no. 1575/qd - dhnh, dated august 31, 2021 of the rector on amending and supplementing certain articles of the regulations on undergraduate training under the credit-based system at Ho Chi Minh University of Banking;

Pursuant to Decision No. 466/QĐ-ĐHNH dated February 28, 2024 of the Rector on promulgating the Regulations on organization and management of undergraduate training at Ho Chi Minh University of Banking;

Based on Decision No. 1076/QĐ-ĐHNH, dated May 8, 2019, issued by the Rector of Banking University of Ho Chi Minh City, Regarding: the promulgation of the "Regulation on Course Registration and Withdrawal in Credit-Based Training System at Ho Chi Minh University of Banking";

The Academic Affairs Office hereby informs all students of the Regular Undergraduate Program and the Part-Time Undergraduate Program of all cohorts about the course registration plan and regulations for Semester 1 – Academic Year 2025–2026 as follows:

## 1. Academic Calendar Convention

Semester 1 (2025–2026) starts from Week 1 and ends in Week 23. Week 1 begins on Wednesday, September 3, 2025.

## 2. Announcement of Class and Exam Schedules:

<sup>\*</sup> Third Registration Round: This is for students to add courses to existing classes that have already been opened by the university and still have available slots. *Note:* Students are not allowed to cancel any registered courses during this period.

- **Procedure:** Students download the Course Registration Form (using the attached template), fill in the information of the courses they wish to register for, and send it to the email address of the class manager.

## 4. Time and Method of Tuition Payment:

- **Time:** From July 28, 2025 to the end of August 10, 2025.
- **Hình thức đóng học phí: Method of payment:** Students access the Online Payment Portal of Ho Chi Minh City University of Banking at <a href="https://e-bills.vn/pay/hub">https://e-bills.vn/pay/hub</a> to check outstanding tuition fees and make payment via the VCB Digibank app, mobile banking apps of other banks, or e-wallets.( user guide for the Online Payment Portal of Ho Chi Minh City University of Banking is attached: <a href="https://e-bills.vn/pay/hub">https://e-bills.vn/pay/hub</a>).

## 5. Verification of Course Registration Results

- tudents of the regular undergraduate program must verify their credit-based course registration results through their personal accounts at <u>online.buh.edu.vn</u>. If there are any questions or complaints regarding the registration results, students must contact the Academic Affairs Office via phone at **028.38.971.638** (56 Hoang Dieu 2 Street, Thu Duc) from **August 18, 2025 to August 19, 2025** (during office hours).
- Students of the part-time undergraduate program must check the registration results previously sent via email with their class manager and make corrections (if any errors are found) on **August 18, 2025**, via phone at **028.38.212.430** (Campus at 36 Ton That Dam, District 1).
- After the above period, the Academic Affairs Office will not resolve any further complaints or adjustments from students.

## **6. Important Notes Regarding Course Registration**

- To ensure accurate and effective course registration, students are required to thoroughly understand the following information and regulation:
- + Register through the specified website to directly access the registration portal applicable to each cohort.
- + Be aware of the prerequisites for each course to be registered and the number of courses required to accumulate knowledge during the semester. **Note:** Priority

should be given to registering for prerequisite courses before registering for other courses.

- + Students must register for a number of credits that complies with the minimum and maximum limits specified in the current academic regulations.
  - ♣ Students currently classified under "academic probation" are allowed to register for a **maximum** study load of **14 credits per semester**, including courses retaken due to prior failure).
  - ♣ The minimum study load for students with "normal academic standing" is 15 credits per semester. For students of Cohorts 39 and 40, the minimum requirement is 6 courses.
  - ♣ Students who register for fewer than the required number of credits or fail to register for any courses during the semester will receive an academic warning, in accordance with the current academic management regulations.
- + Students who fail to fulfill their tuition payment obligations within the deadline set by the Finance and Accounting Department will **not be recorded** in the list of registered courses for Semester 1 of the 2025–2026 academic year.
